#### **Old Business:**

District 3rd Service Event: Mt. Charleston Picnic- Picnic was a success. Gene thanked the committee members for all of their assistance. Gene asked that next year, GSR's add more input with regards to the raffle items.

Lisa discussed T-Shirt sales. Received 100 t-shirts, and had 99 to sell, as one t-shirt was donated. With 52 remaining, we sold less than 50% of the t-shirts that were available. Sold \$290.00 worth of T-shirts, which were purchased for a cost of \$675.00

Gene went over the money: We sold 382 tickets and sales for tickets came in at \$4,589.00. Rough estimate of the picnic's net cost (income less expenses) stands at ~<\$2,050.49> as of 9/19/14.

District 4th Service Event: November 1, 2014 at 11 am. Since David resigned as GSR, the group needs to elect a new chair for the event. Dano volunteered to step up as Chair of the event.
